## **CRITERIA/ ELIGIBILITY**

To deserve consideration for an IIPCIC Award, a nominee must have demonstrated initiative and innovation when handling or investigating an intellectual property or anti-counterfeiting case. Anyone in the IP community, including law enforcement or stakeholder partners and subject matter experts may honour exemplary efforts of an individual, department, team or specific unit by nominating them to be considered for these awards. You may not nominate yourself or an immediate family member for this award.
